HARVESTING NEWS

The LLPA supports reasonable and environmentally sound action to facilitate navigability on Long Lake. For Long Lake, the most appropriate management technique is contracting a mechanical harvester (weed cutter). Harvesting targets invasive aquatic plants such as Curly-leaf pondweed. Curly leaf pondweed produces small flower terminal spikes that rise a few inches above the surface of the water causing the production of turions. Early harvesting before the seeds grow would help reduce the weeds throughout our lake. When this weed decays and dies, it can cause low oxygen conditions and the release of nutrients that can cause algae blooms and the reduction of recreational activities on the lake. Harvesting targets the nuisance levels of aquatic plants in order to benefit watercraft navigation.

This year we are planning on two harvests. The first harvesting will be in late May targeting Curly Leaf Pondweed on Navigational Lanes and a second late June or early July 2022 focusing on navigational lanes and private piers. The harvesting

that is being done is within the parameters of our permit and is fully supported by the DNR. The habitat for fish and other lake organisms are not eliminated.

In 2021, approximately 7,000 cubic yards of plant material were removed at a cost of \$10,500. We usually have the good fortune of having extra funds from generous donors to cover this cost. See the membership form to get more information on donations. Please be generous and keep in mind, we



are 501C-3 non-profit organization. Your contributions may be tax deductible.

According to Onterra, the lake planning group the LLPA hired to develop a lake management plan, there are 44 different weeds in Long Lake, two of which are invasive. They are Curly Leaf Pond weed and Eurasian Water Milfoil. The Curly Leaf Pondweed at least for now is the most prevalent. One single plant that can produce up to 100 turions or seeds. It's the top grower and creates a blanket type affect that blocks out the sun and doesn't allow the good weeds below to grow. Good weeds and vegetation are essential and necessary for fish habitat on Long Lake. We are not alone, Kettle Moraine Lake and Auburn Lake are also harvesting weeds.

In considering making a harvest donation, keep in mind all members benefit from the navigation lanes as it allows you to use the entire lake.

Harvesting donations must be received by June 15, 2022 to have weeds harvested along your pier.
